Mobile App Data Policy – March 2017

This privacy policy sets out how Newline ASP ('we', 'us' or 'our') uses and protects any information that you provide Newline ASP when you use Newline CRM ('Mobile Application').

Newline ASP is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this Mobile Application, then you can be assured that it will only be used in accordance with this privacy statement.

Newline ASP may change this policy from time to time by updating this page. You should check this page from time to time to ensure that you are happy with any changes. This policy is effective from 15th March 2017.

What We Collect

After purchasing the Mobile Application specific license and downloading the Mobile Application, we may collect and store locally the following information:

Device Information:

When you use a mobile device like a tablet or phone to access our Service, we may access, collect, monitor, store on your device, and/or remotely store one or more "device identifiers." Device identifiers are small data files or similar data structures stored on or associated with your mobile device, which uniquely identify your mobile device. A device identifier may be data stored in connection with the device hardware, data stored in connection with the device's operating system or other software, or data sent to the device by Newline ASP.

Information you provide us directly:

User Content (e.g., notes) that you post to the Service.

Finding your contacts' location:

If you choose, to use our "Nearby Contacts" feature to locate contacts in your Customer database, Newline CRM will use your precise location either GPS or network-based.

Telephone and SMS Logs

Log information is automatically reported by your device each time you make a phone call or send a text message to anyone in your NAS customer database. Only the time, date and number are recorded, not the content of the message or call.
